

## Congregational Meeting Information (June 29, 2014)

The following information was shared by Clerk Lori Schmidt at the Congregational Meeting.

- In December, Session interviewed candidates for 3-month Bridge Pastor – selected Rev.
   David Good – contract from February 1 through May 1.
- In the spring, Session felt things were going well and both sides agreed to extend Bridge contract for another 3 months – May 1 through August 1.
- At June's Session meeting, Session approved negotiating a 5-month contract (August 1 through December 31) with Pastor Dave.
- At May's Session meeting, Rev. David Good asked Session to accept him as a candidate for the office of Teaching Elder (Pastor) for BPC. Elders shared they had been hearing similar comments from members wishing Pastor Dave could be our regular pastor. Elders were asked to pray and think about this and be ready to discuss at June's meeting.
- At June's Session meeting, Session voted to affirm Rev. Good as a candidate if the way is clear. Session realizes that "calling a Pastor" is a 3-way partnership between pastor congregation session. Therefore, Session is asking for affirmation from the congregation. A positive vote today does not establish Rev. Good as the installed pastor, but does stand as affirmation of moving forward in the process toward that outcome. Today's approval would mean we would not proceed directly to a Pastor Nominating Committee at this time.
- Present policy for Maumee Valley Presbytery
  is that a "Temporary Pastor" must have served
  three years before a congregation can officially
  extend a call. We would have the next three
  years to evaluate if we want to call Rev. Good
  as our Installed Pastor. If during this time both
  parties feel it is a good fit, then it would lead

- to a final vote to officially extend a call in 2017. Approval of Maumee Valley Presbytery would also be required at that time. Both Susan Meier, Presbyter for Common Life, and Committee on Ministry have seen consulted and are supportive of us in this process.
- Between now and 2017, Rev. Good would be a "Temporary Pastor" – one-year contracts between Session and Rev. Good. Each year a review would be completed by both session/ pastor to see if both parties wanted to continue the relationship.
- When Session met with Susan Meier in December, Session was advised that BPC would need to complete "New Beginnings" process prior to calling a new pastor. "New Beginnings" is a process for us to determine who we are, who are our neighbors, and what is God calling us to do at this time/place. Some of the churches participating in "New Beginnings" are at pastoral transitions; others are looking for direction for the future. We would still be required to complete this process before being allowed to officially "call" Pastor Dave, except now he can be an integral part of the process. Our small group leaders received official training this weekend.
- While today's approval would mean we are not conducting a search for candidates, we've already experienced a working relationship which is extremely valuable for all involved. Both Pastor Dave and members of the congregation have already experienced worship services, committee meetings, Session/Deacon meetings, Sunday school, fellowship, and pastoral care. Transitions are always challenging. A positive vote today would enable us to continue our existing relationship, as well as provide a sense of direction for our near future.
- Paper ballots were distributed. Official count 43 Yes, 0 No to "affirm the process of bringing Rev. David Good as candidate for the office of Teaching Elder of Bluffton Presbyterian Church in 2017".

#### Deacon's Report

- With the help of volunteers from the congregation, the deacons provided a meal following Louise Reichenbach's memorial service and following Dick Reeder's funeral. A reception was held following the memorial service for Bob Barnett.
- Approximately 75 were served at the Community Meal hosted by our church on June 5 at the Senior Center.
- Deacons will not meet in July. The next deacons meeting is August 20, 7:30 p.m.

#### **Bridge Home Health & Hospice** Volunteer Training Courses

Bridge Home Health and Hospice, a non-profit organization providing home health care and hospice services, will offer training courses for prospective volunteers beginning on Tuesday, July 22.

The training will be held in the Wenner conference room at Birchaven Village, located at 15100 Birchaven Lane in Findlay, and will take place for six consecutive Tuesdays from 6:00 to 8:30 PM.

Courses will cover topics such as the basic principles of hospice, understanding the special needs of patients and their families, effective communication, patient care, pain and symptom management, spiritual care giving, and understanding grief and loss.

No previous hospice experience is necessary; however, volunteers must be at least 18 years old.

Following training, volunteers can choose a special area of involvement such as caregiver relief, bereavement, nursing home visitors, gift of dreams, hospice care center, or clerical work.

#### Gifts of Securities Can Save on Taxes

The Session has adopted a gift policy to guide the church's handling of various kinds of gifts and to protect both donors and the church from misunderstandings and disagreements. The policy is posted on the church's website.

One provision of the policy may serve to offer donors the opportunity to save on income taxes beyond the normal deductibility of gifts to the church. If a donor gives appreciated securities to the church, neither the donor nor the church has to pay the capital gains tax that would otherwise be owed. A donor can deduct the full market value of gift securities regardless of the donor's cost basis. And, the church, as a not for profit organization, can sell the securities and incur no tax liability. The donor gets the deduction and credit for a contribution to the church in the amount of the market value, and the church gets the proceeds of the sale. If, on the other hand, a donor sells appreciated securities and donates the proceeds to the church, the donor will incur a capital gains tax liability for the amount the securities have appreciated.

The Session authorized the opening of a securities trading account at Chase Bank for the sole purpose of receiving gifts of securities. The most efficient and easiest method of transferring securities ownership to the church is to have your broker or financial advisor transfer the securities directly into the church's account. If you would like to avail yourself of this tax-saving opportunity, contact Clair Winebar or George Stultz.

#### **Building Restoration!**

With the physical work about to begin, this is the perfect time to prayerfully consider providing a Restoration Project commitment/pledge! The Building Committee and Session have done a great job planning this vital project in a cost effective manner with a local, high quality contractor. It is reassuring to know that we are tending to our responsibility to ensure the immediate and longer term physical integrity of our Church.

If the original commitment drive passed you by, please give thoughtful reflection to providing a commitment/pledge this summer. As you may recall, commitments may be made through the end of 2015, but if a longer commitment period works better for your situation, that is fine as well. Please also remember that all commitments are equally important regardless of their size, and as always, commitments may be updated with changes in personal circumstances. Just like the maintenance on our homes, Restoration is necessary to allow us to serve and worship God now and in the future. Thank you for supporting Restoration!




